 - A) 1) Food Stand fee of \$400.00 paid in full if selling more than (2) two food items.
2) Food Stand fee of \$200.00 paid in full if selling no more than (2) two food items.
 - B) **Photo copy of your Insurance Policy, must accompany your application for Insurance purposes.**
 - C) *Menu of items being served and prices being charged should be returned with this application. Items not eligible for your booth are the following: Cotton Candy, Candy Apples.*
 - D) Fairgrounds will be open for set-up by 8:00 a.m. on Sunday, August 2, 2009.
 - E) All vendor vehicles must be parked outside the gate by 12 noon. **No Exceptions!** No vendor vehicles will be allowed to stay inside the gates on the fair grounds during the hours of 12 noon until midnight. After 12 noon all supplies must be shuttled into the fair grounds. If you should need assistance, Fair Board members will be available to help transport your supplies.
 - F) There will be an additional \$50 fee for electrical hook-ups outside the gates, and \$25 additional fee for all additional electrical plug-ins.
 - G) All Food Stands shall remain on the fairgrounds from August 4 thru August 8, 2009.
 - H) We prefer all Food stands to be set-up and ready to open by 12 noon on Tuesday, August 4, 2009. Food stands shall open by no later than 4:00 p.m. Tuesday through Friday and 12:00 noon Saturday.
